Camera focuses from afar on a woman, slowly comes to a close up. Sitting on the far right side of a couch. A half full glass of water sits next to her. In front of her is a coffee table.

SAMANTHA, Young woman with a lot of life experience in her eyes, sits patiently with her legs crossed and arms to the side.

DR. MILLER (O.S)

It's been about a month since we last spoke. How are things with you?

SAMANTHA:

Things have been.... Good. They're getting better. I've been talking to my friends and they have been an amazing support.

CAMERA CUTS TO A MAN SITTING IN AN ARM LESS CHAIR.

DR.MILLER, middle aged, well dressed man. He sits with a clipboard, his eyes focused on what he is writing.

DR. MILLER:

These friends of yours.... They are quite judgmental of each other. is this correct?

CAMERA CUTS TO SAMANTHA.

SAMANTHA:

They can be a little harsh at times.

DR. MILLER (O.S)

And you crave their acceptance. Is that correct?

CONTINUED: 2.

SAMANTHA:

Well, crave is a strong word.

CAMERA CUTS TO DR. MILLER.

Dr. Miller speaks while still writing on his clipboard.

DR. MILLER:

But you do try hard to make your life as perfect as possible so they will accept you. Correct?

CAMERA CUTS TO SAMANTHA.

She becomes insecure.

SAMANTHA:

I try to take their advice.

CAMERA CUTS TO DR. MILLER.

DR. MILLER:

And is it true that they didn't think too kindly of your son?

CAMERA CUTS TO SAMANTHA

She looks down at the ground. Folds her arms. She is ashamed.

SAMANTHA:

Yes.

DR. MILLER (O.S)

Great, thank you for sharing. Now. Have you been in contact with your son at all?

CAMERA CHANGES TO A WIDE SHOT. BOTH SAMANTHA AND DR. MILLER CAN BE SEEN ON SCREEN.

Dr. Miller still looking straight at his clipboard.

SAMANTHA:

Yes. My son and I have been having a healthy relationship. I see him daily.

DR. MILLER:

(Dr.Miller looks up slowly.)

Daily?

Samantha uncrosses her legs and leans in towards Dr. Miller. She has a confident glow. Like she is doing well.

(CONTINUED)

CONTINUED: 3.

SAMANTHA:

I'm just glad he has forgiven me for the accident.

Samantha reaches over and takes a sip of water.

THE CAMERA CUTS TO DR. MILLER.

Dr. Miller has a confused and worried expression

DR. MILLER:

The accident? Samantha. What happened was no accident. You do remember what happened, Right?

CAMERA CHANGES TO A BIRD EYES VIEW OVER SAMANTHA.

Samantha starts fumbling with her fingers, she recrosses her legs.

SAMANTHA:

I was drinking that night. I drove off the road.

CAMERA CUTS TO DR. MILLER.

Puts the clipboard down on the coffee table. He leans in closer to Samantha.

DR. MILLER:

The paramedics found your vehicle in the lake.

THE CAMERA FACES SAMANTHA.

SAMANTHA:

No.

CUTS TO DR. MILLER

DR. MILLER:

With you, curled up on the bank.

CUTS BACK TO SAMANTHA, SLIGHT ZOOM.

Samantha puts her hands over her face.

SAMANTHA:

No.

CAMERA CUTS BACK TO DR. MILLER

CONTINUED: 4.

DR. MILLER:

Inside was your ten year old son. Tied up.

CAMERA CUTS BACK TO SAMANTHA. MID WAY ZOOM.

She is crying and rocking back and forth. Head still in her hands.

SAMANTHA:

No.

CAMERA CUTS TO DR. MILLER

DR. MILLER:

Samantha. You killed your son because one of your friends. Didn't like him.

CAMERA CUTS TO SAMANTHA. FULL ZOOM.

She releases her head and yells.

SAMANTHA:

NO!!!

CAMERA CUTS TO THE LEFT SIDE OF DR.MILLER

Dr. Miller reaches with his left hand and turns on his walkie talkie.

CAMERA FOLLOWS THE WALKIE TALKIE TO DR.MILLERS EAR.

CAMERA CUTS BACK TO SAMANTHA.

DR. MILLER (O.S)

Come get her.

CAMERA FOCUSES ON THE LEFT SIDE OF SAMANTHA. A MAN ENTERS.

NURSE, Middle aged man dressed in scrubs enters room via hallway.

Samantha is taken out of the room. Still crying.

CLOSE UP OF DR. MILLER.

Dr. Miller pulls out a voice recorder.

DR. MILLER:

Dr. Miller. Time is 1500 hours.
Date. November 18th 2016. Patient
42 continues to forget past events.
(MORE)

(CONTINUED)

CONTINUED: 5.

DR. MILLER: (cont'd)
Still believing that her son is
alive. She also reviled that she is
now speaking to him and her friends
on a daily basis. Which is
impossible. Patient 42, Samantha
Heights suffers from dementia and
severe Schizophrenia. She continues
to get worse each time I see her. I
recommend more, intense
electroshock.
